- F. 500 block of North Chester Street (both sides, both sides posted);
- G. 200 North Chester Street (both sides, both sides posted);
- H. 400 block of North Collington Avenue (both sides, both sides posted);
- I. 500 block of North Collington Avenue (both sides, both sides posted);
- J. 700 block of North Collington Avenue (both sides, both sides posted);
- K. 800 block of North Collington Avenue (odd side, odd side posted);
- L. 1900 block of North Jefferson Street (odd side, odd side posted);
- M. 2000 block of Jefferson Street (both sides, both sides posted);

- N. 2100 block of Jefferson Street (both sides, both sides posted);
- O. 2200 block of Jefferson Street (both sides, both sides posted);
- P. 2000 block of McElderry Street (both sides, both sides posted);
- Q. 2200 block of McElderry Street (both sides, both sides posted);
- R. 1900 block of Orleans Street (both sides, both sides posted);
- S. 2000 block of Orleans Street (both sides, both sides posted);
- T. 2100 block of Orleans Street (both sides, both sides posted);
- U. 500 block of North Patterson Park (both sides, both sides posted);
- V. 400 block of North Washington Street (both sides, both sides posted);
- W. 500 block of North Washington Street (odd side, odd side posted);
- X. 400 block of North Wolfe Street (odd side, odd side posted);
- Y. 600 North Chester Street (no sign posted); and
- Z. 2000 block of E. Fayette Street (even side, even side posted).
